We will not offer any exams for the Commercial license. Anyone wishing to take the Registered Technician exam must first apply through VDACS and be approved prior to taking that exam.

Profitable No-Till Production

This year's conference will focus on the economic impacts of no-till production. Two practitioners of no-till will share their experiences in developing profitable operations.

Kevin Matthews farms extensive acreage in the piedmont region of North Carolina. His farm encompasses rich river bottom soils and upland clay soils.

Jay Hundley is a grain farmer from the Northern Neck of Virginia. He will share the evolution of practices that have resulted in his way of farming today.

Monsanto representative, **David Mayonado** will provide the latest information for properly using the new <u>dicamba</u> tolerant soybean technology.

Dr. Sally Taylor, Va Tech entomologist, will review the goals of a new research project to investigate an integrated pest management approach to mitigate crop damage from slugs.

Kevin Matthews is a farmer from the Yadkin River Valley in North Carolina. His farming operation includes over 6,500 acres plus nearly 800 acres of custom work. Kevin investigates new technologies and utilizes test plots with a focus in no-till conservation and irrigation management. He has adopted subsurface irrigation on many acres.



James "Jay" Hundley, III is a third generation farmer from Champlain, Virginia. His operation, Cloverfield Enterprises, raises corn, soybeans, wheat and barley on about 7,500 acres in Essex, Caroline and King George counties.

David Mayonado has served as a Technology Development Representative for Monsanto for the past 25 years. His presentation will focus on dicamba tolerant soybean stewardship. The EPA and the dicamba manufacturers have developed new product labels and training requirements to promote proper use of this new technology.
